Our Eco-warriors have been invited to be part of a very exciting Clean Air Project.

Southampton City Council is working with local schools to improve awareness of the impacts of pollution and reducing its impact in and around schools.

The Clean Air project will consist of providing schools with an engagement pack, this will provide 3 lesson plans (1 being an outside fieldwork activity in the school grounds), introduction assembly material, traffic count workbook, campaign ideas, action plans and more.

The project will also enhance air quality monitoring providing the top 20 schools with a free air quality sensor or diffusion tube. This will lead onto creating clean air routes to school maps to reduce the student's exposure to air pollution.

At the end of the project, Southampton City Council will be offering a Clean Air Delivery fund to empower schools to deliver projects they have identified could reduce the impact of poor air quality. These may include things like green walls, cycle storage, air quality monitoring and applying for infrastructure changes.

Why be a part of the project?

- Improve awareness of the air quality challenge in Southampton and near the school
- Reduce the impact of pollution on students
- Reduce pollution in the local area for the benefit of other residents
- Contribute towards student personal development
- Link with other schemes and accreditations including My Journey and Eco Schools
